










Building Land Bank in the POGB

- Participation in 9 Gold Projects in the POGB >75k hectares





Drill Results From Veta Zone






Select drill results from 2021 / 2022 diamond drill campaigns

- 6 diamond drill holes completed in June 2022
- Total 2,081 metres of drill core returned over 800 metre strike length
- Drill pad 5 & 6 closer to Au bearing quartz veins
- Two visible gold intercepts
- Failed to intercept high grade Au at depth
- Zones to SW prioritized for drilling

Usicayos Gold Discovery Zones






- 4.5 X 1.5 km of mineralized gold structures
- All zones on private ground
- Cayos & newly acquired Sol de Oro zones prioritized for drill testing
- Cayos & Sol de Oro zones host more defined structures
- Modified DIA to allocate 35 drill pads to Sol de Oro & Cayos Zones

- Drill remains at site

Winshear Gold - Gaban Gold Project





Palamina's Land Bank in the Puno Orogenic Gold Belt (POGB)






- San Gaban and Inambari rivers drain into Madre de Dios alluvial goldfields



Galena Silver Copper Project





Galena: Four Silver Copper Zones

In 2022 two internal claims acquired + 4,800 hectares staked from GoldSpot study Rosa/Gris Zones being investigated to host a Ag-Cu Carbonate Replacement Deposit ('CRD')

Results from 361 samples collected in 2022:



*Five select samples from prior and 2022 sampling programs with highest silver values for each zone.

*Five select samples from prior and 2022 sampling programs with highest copper values for each zone

Rosa Zone: Mapping, rock and soil geochemical sampling at the Santa Rosa mine, in the Rosita area 0.4 km's to the north and the Mina Rosita Huayrapata area 3 km further to the northwest.

Gris Zone: Mapping, rock and soil geochemical sampling of an argentiferous breccia in the newly acquired historic Chapparo mine area north west of the historic Gaspar mine.


